On-site registration will only be available if the trial does not fill before the closing date. Temperament tests are open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the Foundation Stock Service (FSS) program, individually registered with a foreign or domestic registry organization whose pedigrees are acceptable for AKC registration, dogs granted a Purebred Alternative Listing (PAL) number, dogs with AKC Limited or Conditional Registration, or dogs enrolled in the AKC Canine Partners program. Dogs with breed disqualifications and monorchid/cryptorchid dogs are eligible to participate. NO REFUNDS WILL BE GIVEN.
